I have not completed a driving safety course that is not yet reflected on my driving record, and I have not completed a driving safety course in the last twelve months of the date of this citation. I am enclosing the requested items and am sending by certified mail if not bringing in person. My offense was not for: passing a school bus, going 25 mph over the posted speed limit, and I do not have a commercial drivers license. I am enclosing \$109.10 (\$134.10 if in school zone), cashier check or money order only and a copy of my valid Texas Drivers License, a copy of liability insurance with my name as a listed driver, and a stamped, self-addressed envelope.
