Utility Dept.: Jacob Ashton was not in attendance at meeting


Police Dept.: Chief Medina still needs officer, gave statistic reports

Maintenance: Mr. Goodson advised he had sold both the dump truck and 2005 Chevy Pick Up. They have been filling potholes.


XI. Announcements: None
