*COMMUNITY SERVICE:

IF YOU WISH TO PERFORM COMMUNITY SERVICE FOR SATISFACTION OF YOUR FINE, YOU MAY SEND A WRITTEN REQUEST ON OR BEFORE YOUR COURT DATE, WITH A SELF-ADDRESSED, STAMPED ENVELOPE. STATE LAW ALLOWS \$150 CREDIT FOR EACH 8 HOURS OF COMMUNITY SERVICE.

ALL PERSONS UNDER 17 must appear **in person** before the judge with a parent or legal guardian or proof of marriage. NO PLEAS ACCEPTED BY MAIL.

PERSONS UNDER 18 CHARGED WITH TOBACCO OFFENSES must appear **in person** before the judge.

PERSONS UNDER 21 CHARGED WITH ALCOHOL-RELATED OFFENSES must appear **in person** before the judge with a parent or legal guardian.
